The Standing Committees shall be Caring Service, Christian Life, Communication, Gospel Outreach, Organizational Resources, Special Focus Ministries, and Endowment.

Rationale: establish Endowment as a Standing Committee thus giving the Endowment Chairman voice and vote on the Board of Directors.
